

# Funding Requirements

## What are the minimum requirements for funding?

We currently provide financing for eCommerce and Consumer SaaS (software as a service) companies. At this time we are unable to provide capital to service-based, sole proprietor, self-employed, or agency companies. To receive funding offers, your business must meet our eligibility requirements.

## What types of companies do you fund?

We are able to fund eCommerce Products, SaaS Businesses + Marketplaces, Apps, eCommerce Web Services, and webinars, training videos, online certifications.

We are unable to fund Travel / Event Operators (anything directly related to airports/airlines), Professional Services - Media/Agency/Digital Consultancies/Marketing Services (Exemptions can be made for those professional services at scale operating in multiple cities), Paraphernalia (only fundable for Canadian businesses), Cannabis Products (Consumable is not fundable), Vaping Products, Wholesale, Dropshipping, One-time services / Non-Scalable, Capital Provider, Brick and Mortar, Gambling (subject to review), Narcotics/Illegal Substances/Illicit Activities, Weapons, Hatred Products, Tobacco Products, Pyramid Schemes, Marketplaces, Auction, Spiritual services / online confessionals / psychics, and Crypto.

## Marketing Capital & Inventory Financing:

- 6+ months of revenue greater than 10k/month from [connected sales platform\(s\)](#)
- incorporated (i.e. corporations, LTD, or limited liability companies) in Canada, USA, Australia, United Kingdom, Ireland, Belgium, Germany, Finland, Austria and the Netherlands

## What is the application process?

It's easy!

- Receive Funding - after a short review by our diligence team, if approved, the funds will be available to you via a virtual VISA card or our Pay a Vendor platform. Please note that Inventory Financing advances will not have a virtual VISA card.

## How Long Does the Clearco Funding Process Take?

The entire process (application, offer, approval, funded) can be completed in as little as three to five business days. Large advances and applications requiring special considerations or analysis may take longer. The “Hold tight we are crunching the numbers” status on your account page indicates that our calculator is currently reviewing your application and business data to determine your Clearco funding eligibility. Please keep a lookout in your email inbox for a message when your offers are available. Only those who are eligible will receive offers, however, our ClearMatch & Insights services are available to everyone at no cost.
